

Terms of Use

1. Introduction

1.1. Please read these terms of use (“Terms of Use”) carefully before using this website (“Website”). Accessing and using the Website indicates that you accept and agree to comply with the Terms of Use. If you do not agree, do not use the Website.

1.2. The Website is operated, and these Terms of Use are issued, by SwissOnly, UAB, Konstitucijos pr. 7, 09308 Vilnius, Lithuania (“Swissonly”, “We”, “Us”, “Our”).

1.3. Swissonly may revise these Terms of Use at any time. You are bound by any such revisions and should therefore periodically visit this page to review the then-current terms to which you are bound.

2. Purpose and Content of the Website

2.1. All information and materials on the Website are presented solely for the purpose of providing general information on, and promoting, products and services of Swissonly.
